# Academic Senate Meeting Minutes May 22, 2023 G219 and ZOOM (Hybrid Format)

#### I. Welcome and Call to Order (Martin)

The meeting was called to order by Dr. Martin at 2:02pm.

## II. Approval of February Meeting Minutes (Martin)

The minutes were approved.

## III. Updates and New Business (Martin and others)

- a. Action Item: Resolution on Parental Leave Distributed as part of Agenda
  - i. Passed by the Faculty Affairs committee on May 12, 2023
    - 1. Exact language included as part of agenda.
    - 2. <a href="https://academicsenate.uams.edu">https://academicsenate.uams.edu</a>
    - 3. Several people stated that this resolution is very important to the mission and vision of the organization.
    - 4. Discussion:
      - a. Regarding this resolution type, has there ever been brought forth before as far as current senate leadership know, there has not been a resolution of this type.
      - b. Reasoning behind the effective dates of 2026 for 4 weeks of leave and 2029 for full 12 weeks of leave: Wanted to give leadership some time to plan for catastrophic leave bank accrual for an effective pool; want the resolution to be feasible and dates are "by", so it could happen earlier; 1st 4 weeks of paid maternity leave is already in place, so would be quicker to upstart; full 12 weeks of leave to include paternity leave would take longer to upstart
      - c. Act 770 why does it not automatically apply to UAMS now since it is a law? The bill says they "may" put in a catastrophic leave policy for Higher Eds, so the "may" verbiage means that they can do nothing, enter the state bank of catastrophic leave, or create their own. Phased in approach means that the 4-week leave will not require UA sys board approval or legislative branch; however, 12-week parental leave will require either UA sys board approval or legislation (political backing)
      - d. How does the pool and donations work? People can choose to voluntarily donate leave, people can donate if they are over the 240 limits, or they could donate if they are resigning or retiring.

- 5. Non-binding online poll was completed: 25 votes total (21 said yes, 4 chose yes, but with modifications)
  - a. Dr. Martin asked for a discussion on the floor of modifications from the 16% that voted yes with mods: one response suggested that equitability would be more provided if it wasn't a pool that staff did not have to donate and would suggest moving up the timeline.
- 6. Call the question: 1<sup>st</sup> Dr. Gressler and 2<sup>nd</sup> by Ron Sanders; the resolution was voted on by the Academic Senate with 18 yays, 0 nays, 0 abstain, and 5 were absent; the resolution passes through the academic senate and will move onward to UAMS leadership.
